Friendly Reminders:

- No service will be scheduled if there is an outstanding balance for service, storage, dockage, etc.
- **YOU will need to pump out your waste system (We will not have dockhands present to pump waste tanks)**
- All service work must be paid in full before the boat leaves Castaway Marina.
- Payment for service invoices is due upon receipt. If payment is not received within 30 days, late fees will apply each month.
- If storing your boat **do not fill the gas tank over ¾ full** (gas expands in the warmer spring months and can come out the vent).
- With today's ethanol blended gas, it is very important for you to add stabilizer and run it through the engine during your last boat ride.
- Please make sure all batteries are fully charged before leaving boat.
- Please remove ropes, life jackets and other items from storage compartments adjacent to engine.
- Boats must be picked up within 10 DAYS of service being completed (\$20.00/day fee will be charged thereafter)
- Castaway assumes no responsibility for damage caused to canvas/eisenglass by removing and installing. Camper tops should be removed and regular covers installed (if you have them).
- Please leave fresh water tanks empty if possible.

**TERMS AND CONDITIONS:** BY THE EXECUTION OF THIS SERVICE REQUEST, THE UNDERSIGNED AGREES TO THE FOLLOWING TERMS AND CONDITIONS:

1. ALL PAYMENTS FOR SERVICE, PARTS AND ANY OTHER FEES ARE DUE WITHIN THIRTY (30) DAYS OF DATE OF INVOICE OR PRIOR TO REMOVAL OR DELIVERY OF THE BOAT/TRAILER FROM CASTAWAY MARINA PROPERTY, WHICHEVER IS EARLIER. ANY PAYMENTS NOT MADE WITHIN WHEN DUE SHALL ACCRUE INTEREST AT THE RATE OF 1.5% PER MONTH. CASTAWAY MARINA RESERVES THE RIGHT TO DENY ACCESS TO, AND RETAIN POSSESSION OF, ANY BOAT/TRAILER UNTIL ALL SUMS DUE CASTAWAY MARINA ARE PAID IN FULL. ALL BOATS/TRAILERS SHALL BE REMOVED FROM CASTAWAY MARINA PROPERTY WITHIN TEN (10) DAYS OF COMPLETION OF WORK BY CASTAWAY MARINA AS CASTAWAY MARINA MAY NOTIFY BY EMAIL OR TELEPHONE CALL TO OWNER. THEREAFTER, STORAGE FEES SHALL ACCRUE AND BE DUE AND OWING TO CASTAWAY MARINA BY OWNER AT THE THEN APPLICABLE STORAGE RATES POSTED AT CASTAWAY MARINA PROPERTY, CURRENTLY \$ \_\_\_ PER DAY. IN THE EVENT OF NON-PAYMENT, CASTAWAY MARINA SHALL HAVE A LIEN ON THE BOAT/TRAILER AND MAY ENFORCE ANY RIGHTS, INCLUDING SALE OF THE BOAT/TRAILER AT AUCTION, THAT CASTAWAY MARINA MAY HAVE UNDER NEW YORK LAW.

2. ANY CLAIM ARISING FROM ANY WORK PERFORMED UNDER THIS AGREEMENT MUST BE BROUGHT WITHIN SEVEN (7) DAYS OF THE DATE ON WHICH OWNER DISCOVERS OR SHOULD HAVE DISCOVERED THE FACTS OR CIRCUMSTANCES GIVING RISE TO SUCH CLAIM. CASTAWAY MARINA SHALL NOT BE LIABLE FOR ANY DAMAGE, FACTS OR CIRCUMSTANCES ARISING FROM CASTAWAY MARINA SERVICES UNDER THIS AGREEMENT THAT ARE WORSENEED BY ANY ACT OR OMISSION BY OWNER OR ANYONE USING THE BOAT/TRAILER BY OR THROUGH OWNER. SERVICE WORK LABOR IS WARRANTED FOR A PERIOD OF THIRTY (30) DAYS FROM COMPLETION OF SERVICE BY CASTAWAY MARINA, PROVIDED THAT FOR WINTERIZATION SERVICES, THE WARRANTY PERIOD FOR WINTERIZATION WORK ONLY SHALL BE EXTENDED TO THE JUNE 1<sup>ST</sup> FOLLOWING THE DATE OF COMPLETION OF SUCH WINTERIZATION SERVICES. IF APPLICABLE AND AVAILABLE, ANY WARRANTY ON PARTS SHALL EXTEND TO THE WARRANTY ISSUED BY THE MANUFACTURER OR SUPPLIER THEREOF, PROVIDED THAT NO SUCH WARRANTY SHALL BE CONSTRUED TO BE A GUARANTEE OF SUCH WARRANTY BY CASTAWAY MARINA AND CASTAWAY MARINA MAKES NO REPRESENTATION OR WARRANTY AS TO THE AVAILABILITY, TERMS OR CONDITIONS OF SUCH WARRANTY. IT SHALL NOT BE A CLAIM TO SUCH WARRANTY THAT THE BOAT/TRAILER REMAINED IN CASTAWAY MARINA'S POSSESSION FOR ANY SEASONAL PERIOD. OWNER'S ACCEPTANCE OF THE BOAT/TRAILER SHALL BE DEEMED ACCEPTANCE OF ALL SERVICE PERFORMED AND PARTS SUPPLIED, SUBJECT ONLY TO THE FOREGOING WARRANTY. FOR REPLACEMENT ENGINES OR LOWER UNITS, CASTAWAY MARINA MAKES NO WARRANTIES, EXPRESS OR IMPLIED, AS TO ENGINES OR LOWER UNITS, AND OWNER SHALL LOOK SOLELY TO THE MANUFACTURER OR SUPPLIER FOR ANY APPLICABLE WARRANTIES FOR SUCH ENGINES OR LOWER UNITS. NO OTHER WARRANTIES, EXPRESS OR IMPLIED, ARE MADE, REPRESENTED OR OFFERED BY CASTAWAY MARINA.

3. THE PARTIES EXPRESSLY AGREE THAT CASTAWAY MARINA'S TOTAL LIMIT OF ANY LIABILITY ARISING FROM OR RELATIVE TO SERVICES SHALL BE THE TOTAL AMOUNT OF ANY SUMS PAID TO CASTAWAY MARINA FOR SUCH SERVICES. CASTAWAY MARINA SHALL HAVE NO LIABILITY FOR PARTS SUPPLIED AND OWNER SHALL LOOK SOLELY TO THE WARRANTY, IF ANY, OF THE MANUFACTURER OR SUPPLIER OF SUCH PARTS. NOTWITHSTANDING ANY PROVISION OF THIS AGREEMENT TO THE CONTRARY, IN NO EVENT SHALL CASTAWAY MARINA EVER BE LIABLE TO OWNER FOR ANY ECONOMIC, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, INCLUDING BUT NOT LIMITED TO LOST PROFITS OR LOSS OF USE OF ANY BOAT, TRAILER OR OTHER PROPERTY.

4. IN THE EVENT CASTAWAY MARINA FINDS IT NECESSARY TO SEEK LEGAL COUNSEL FOR THE ENFORCEMENT OF ANY TERM OR PROVISION OF THIS AGREEMENT OR FOR COLLECTIONS OF ANY AMOUNTS DUE HEREUNDER OR ANY INVOICE ISSUED BY CASTAWAY MARINA TO OWNER THEN TENANT SHALL PAY, UPON DEMAND, ANY LEGAL FEES OR COSTS INCURRED BY CASTAWAY MARINA ARISING FROM ANY SUCH ENFORCEMENT, REGARDLESS OF WHETHER OR NOT ANY LEGAL ACTIONS ARE COMMENCED. OWNER CONSENTS TO THE JURISDICTION OF THE COURTS OF WARREN COUNTY, NEW YORK, FOR ANY DISPUTE ARISING FROM THIS AGREEMENT. OWNER WAIVES ANY RIGHT TO JURY TRIAL AND ANY RIGHT TO REMOVE ANY SUCH ACTION ARISING FROM THIS AGREEMENT TO ANY OTHER COURT, INCLUDING BUT NOT LIMITED TO ANY FEDERAL COURT. OWNER CONSENTS TO THE SERVICE OF ALL NOTICES, CLAIMS, INVOICES AND CORRESPONDENCE, VIA ANY EMAIL ADDRESS PROVIDED BY OWNER TO CASTAWAY MARINA, AND AT CASTAWAY MARINA'S ELECTION BY FIRST CLASS MAIL.

5. CASTAWAY MARINA DOES NOT OFFER OR PROVIDE GARAGEMEN'S INSURANCE COVERAGE FOR ANY BOAT OR TRAILER IN CASTAWAY MARINA'S POSSESSION. IN THE EVENT OF FIRE OR OTHER CATASTROPHIC LOSS, OWNER SHALL LOOK SOLELY TO ITS OWN INSURANCE FOR ANY CLAIM FOR LOSS, EXCEPT FOR THE GROSS NEGLIGENCE OF CASTAWAY MARINA. OWNER WAIVES ALL RIGHTS OR CLAIMS OF SUBROGATION AGAINST CASTAWAY MARINA ON BEHALF OF OWNER AND OWNER'S INSURANCE COMPANY, GUESTS AND INVITEES OF OWNER RELATIVE TO OWNER'S BOAT/TRAILER.

6. CASTAWAY MARINA IS NOT RESPONSIBLE FOR ANY ARTICLES LEFT IN OR ON ANY BOAT/TRAILER LEFT IN CASTAWAY MARINA'S POSSESSION.

7. CASTAWAY MARINA IS NOT RESPONSIBLE FOR ITS INABILITY TO CARRY OUT ANY SERVICE OR WORK UNDER THIS AGREEMENT DUE TO GOVERNMENTAL REGULATIONS, GOVERNMENT ENFORCED SHUTDOWNS, WAR, STRIKES, PANDEMIC, WEATHER, OR ACTS OF GOD, SUPPLY CHAIN INTERRUPTIONS, UNAVAILABILITY OF PARTS, WARRANTY CLAIM DELAYS, OR ANY OTHER MATTER BEYOND ITS CONTROL.

8. ANY DATES FOR DELIVERY OR SERVICES ARE APPROXIMATE ONLY AND NOT GUARANTEED. CASTAWAY MARINA SHALL NOT BE RESPONSIBLE FOR CLAIMS, LOSSES OR DAMAGES ARISING FROM OR RELATIVE TO OWNER'S PLANNED USAGE OF THE BOAT/TRAILER FOR ANY REASON.
